

Original work is expected as the papers will be put through plagiarism testing software. Selected research papers of the conference will be published in UGC Indexed Journal International Journal of Advance & Innovative Research (ISSN:2394-7780) and Impact Factor: 7.36 (UGC Journal No. 63571)
